Terms and Conditions for Campbelltown City Soccer Club ("CCSC") Academies

- 1. Our emphasis is on fun & fitness. Children can join with any level of skill or fitness (even if they've never played or trained before). Children are given plenty of encouragement to improve on their soccer skills and enjoy their progress. As the training is quite exclusive, each child will be coached to their skill level.
- 2. Each child should bring a water bottle, snacks and either soccer boots (preferred) and/or running shoes. Each child also needs to bring their own shin guards.
 - NB. Children will not be able to take to the pitch without shin guards. There will be no exemptions.
- 3. We encourage you to also bring sunscreen or a wet weather jacket depending on the weather.
- 4. Children should wear appropriate sporting attire and have any applicable medications on hand that they may require on the day. We encourage white shorts and white socks, but this is not necessary.
- 5. CCSC and/or their representatives will always try to accommodate special needs and medical requirements, and all children are welcome regardless of any needs they may have. We ask that you bring any applicable medications or medical aids with you to ensure the safety of your child.
- 6. Please outline any medical or special needs your child may have where applicable during registration.
- 7. You may cancel prior to 72 hours of the academy commencing. To notify CCSC of your cancellation, you will need to send a Direct Email to CCSC. You will be refunded your payment less 10% processing & administration fee.
- 8. If a parent or guardian cancels attendance of the Child less than 72 hours before the commencement of the academy, there are no refunds available (except in the event of documented proof of the child's illness, by way of doctor's certificate, in which case a cancellation with less than 72 hours' notice will result in a refund being provided).
- 9. I confirm that I will advise my child that they must obey at all times every direction or instruction CCSC and/or their representatives when participating in the Academy. If children do not follow directions, CCSC and/or their representative may refuse to allow children to continue to participate in the Academy.
- 10. Parents or guardians are encouraged to clearly label their child's belongings and ensure that nothing of great monetary value is brought to the Academy. Neither CCSC and/or their representatives take responsibility for loss of personal items at the Academy.
- 11. CCSC and/or their representatives are committed to your privacy and will only hold the information you have provided for the purpose of running the Academy. You have the right to access the personal information that we hold concerning your child/children, and to request correction of any errors in it.
- 12. Parents or guardians must abide by all Academy rules, including those relevant to the venue, including general specific codes of conduct.
- 13. Once an Academy has commenced; there is no refund, however:
 - 13.1. if a session of the academy is cancelled due to Weather Policy or any unforeseen circumstances which are not controlled by the CCSC and/or their representatives, then CCSC and/or their representatives <u>may</u>:
 - 13.1.1. extend the time of the academy; or
 - 13.1.2. arrange for make-up session, to make up for any lost time

If the CCSC and/or their representatives is unable to practicable arrange for a make-up session, to make up for any cancellation, no refund will be provided.

- 13.2. if a session of the academy is cancelled by the CCSC and/or their representatives, then CCSC and/or their representatives may:
 - 13.2.1. extend the time of the academy;
 - 13.2.2. arrange for a make-up session, to make up for any lost time; or

If the CCSC and/or their representatives are unable to arrange for a make-up session, to make up, to make up for any cancellation, a refund for any lost time, will be provided less a non-refundable 10% process & administration fee.

- 14. If a parent/guardian cancels attendance due to long term medical condition which includes documented proof of the child's illness by way of doctor's certificate, and is as a result of:
 - Sports injury exceeding four weeks;
 - Illness exceeding four weeks; or
 - Family illness or medical circumstances that hinders the child's attendance (this will be at the discretion of CCSC).
 - 14.1. Then the Organiser will provide a refund for any outstanding sessions effective from the time of notification, subject to the following:
 - 14.1.1. Notification of any cancellation, due to long term medical condition, will need to via a Direct Email to CCSC.
 - 14.1.2. You will only be refunded for outstanding sessions that your child has remaining from the date of receipt of your Direct Email to CCSC less 10% processing & administration fee.
- 15. I understand that it is not the responsibility of CCSC and/or their representatives to monitor who collects the child if the child willingly accompanies the person upon leaving.
- 16. I understand, represent and agree that:
 - 16.1. I cannot bring any action, claim or proceedings against CCSC and/or any representative for any injury, loss, or damage sustained or incurred by the child (and I make this agreement on behalf of the child); and
 - 16.2. The representation I have made about the child's pre-existing injuries and treatment regime are accurate to the best of my knowledge, will be attached to this document and provided on the day, in writing, and may be relied upon by CCSC and/or any representative.
